#### INDEPENDENT AUDITOR'S REPORT

#### The Acting Department Secretary

We audited, in compliance with the Loan Agreement No. 8335-PH dated have April 2, 2014, between the Republic of the Philippines, thru the Department of Social Welfare and Development (DSWD) and the International Bank of Reconstruction and Development (IBRD), the accompanying Statement of Sources and Application of Funds (SSUF) on the Advance Account No. 3124-0064-64 and Current Account No. 3122-1024-40 for Kapit-Bisig Laban sa Kahirapan — Comprehensive and Integrated Delivery of Social Services: National Community Driven Project (KC NCDDP) as at December 31, 2017.

#### Opinion
