What is Community-Driven Development (CDD)?



Why should we Institutionalize CDD?

Community-Driven Development is a process that encourages citizens to be more active in their community's development.

CDD values and works under the principles of:

- **Participation;**
- **Inclusivity;**
- **Transparency;**
- **Accountability; and**
- **Sustainability**

CDD empowers people by giving them control and decision-making powers over resources in their communities. It allows communities to maximize limited resources by prioritizing their most pressing needs.

CDD institutionalization will empower communities through participation in the design, development, implementation, and sustainability of poverty-alleviation and disaster risk-reduction projects.

CDD will complement the Local Government Code by providing mechanisms to operationalize and sustain self-reliant communities through a proven system of informing, developing, and harnessing constituents to become resilient.

KALAHI CIDSS has been championing CDD for over 15 years. Through CDD, KALAHI has demonstrated success in poverty alleviation, community empowerment, and participatory local governance across the country.



Enacting the CDD Law in the Philippines

Our proposed CDD Law will feature the following:

- I. **Institutionalization and operationalization of the CDD approach as a national strategy for inclusive growth and social protection;**
- II. **Creation of an Inter-Agency Advisory Council on CDD Institutionalization for policy development; and**
- III. **Creation of a CDD Knowledge Resource Center for continued research and development of the CDD Approach**
